POLICY SUMMARY

This policy provides guidance on the use of institutionally provided online data collection software for surveys and research; identifies circumstances under which approvals are required for students to gain access; identifies the necessity of Institutional Review Board (IRB) approval for human subject research, and identifies related policies and procedures.

POLICY**Policy Statement**

All human participant research conducted by SUNY Buffalo State College students using Buffalo State College resources must receive prior approval from Buffalo State College's [Institutional Review Board \(IRB\)](#).

Student access to institutionally-provided online data collection software is restricted by the following:

1. Student access to online data collection software for academic endeavors must be requested by a member of the faculty supervising the student's work. Once the student has an account, the student will retain his/her access to online data collection software for the duration of his/her studies at SUNY Buffalo State.
2. Student access to online data collection software for Buffalo State College business must be requested by the director or head administrator of the office supervising the student. Once the student has an account, the student will retain his/her access to online data collection software for the duration of his/her studies at Buffalo State College.
3. Students who wish to publish surveys to more than 50 campus constituents must get approval from the Campus Survey Committee. This committee includes the Associate Vice President for Curriculum and Assessment, the Director of the Institutional Research Office, and a senior research professor appointed by the provost.

Background

Buffalo State College provides an online data collection tool, Qualtrics, for use at no cost by Buffalo State College students. Users can create and distribute their own surveys and gather information in support of the educational mission and organizational goals of Buffalo State College. Qualtrics has been reviewed by Information Technology (IT) and approved for conducting surveys at SUNY Buffalo State College.
